Dear TISD Staff:

The Taylor ISD CDC is planning for the 2024-2025 school year. This benefit is for TISD employee children, stepchildren, grandchildren, and teen parents that are enrolled and attending at Taylor High School/Achievement Center. The CDC is for children ages six weeks to 3 years old. Children who will be 4 years old by Sept. 1, 2024 are asked to obtain other means of child care. Hours of operation will be from 7:00 a.m. to 5:00 p.m., Monday through Friday.

To secure a slot for your child for the next school year, we ask that you complete and return the attached form with your \$50.00 annual supply fee/deposit (per child) by May 29, 2024. This fee will be used for supplies for your child's classroom.

Child care tuition for 2024-2025 will be \$750.00 for children 6 weeks to 17 months. All other ages will be \$700.00 per month. Children enrolled in Pre-K 3 who ride the bus to the CDC after lunch will be charged half of the normal rate. CDC graduates who ride the bus from Pre-K 4 and Kindergarten, will be charged \$200 per month. Tuition payment options are available and will be payroll deducted. (See payroll deduction table). Please contact the CDC director if you have questions or need more information.


The CDC will be open to care for your children beginning 8/5/2022. WE WILL NOT BE OPEN FOR NEW TEACHER ORIENTATION.
